With 21 years of experience in advancing policy, innovation and resource mobilization to protect biodiversity for nature and for people, Klaas believes the way forward lies in cross-boundary approaches, both in the physical realm of pristine marine protected areas as well as through inter-disciplinary pathways to innovation, knowledge sharing and increasing capacity.
